

Document Descriptions

The following two **certified court documents** from Superior Court of California County of Los Angeles Case BP125551 prove Cynthia Mildred Miles' immunity is unconditional (for all matters) and irrevocable (permanent). Her immunity is due to her accredited "legal status" which is in **no way** connected to any group, terrorist or otherwise.

In Los Angeles Superior Court Case BP-125551, she is court recorded and acknowledged as an 'accredited American sovereign.' To confirm the permanent and all-encompassing nature of this recognition please see the Montevideo Convention on Rights and Duties of States of 26 December 1934 which the United States ratified on July 13th, 1934.

Specifically, **Article 6**: "...Recognition is unconditional and irrevocable." And also **Article 7**, "The recognition of a state may be express or tacit..." As well as **Article 3**, "...Even before recognition the state has the right to defend its integrity and independence...The exercise of these rights has no other limitation than the exercise of the rights of other states according to international law." Please note, the word 'state' is a contraction of—estate.

See also Davis v. Coyle, 280 F. 648 (1922), No. 195 280 F. 648, 650 (emphasis added), "...In the interpretation of statutes the principle is old and well established that the crown is **not bound by a statute unless named in it.**" And please see Decisions of the Comptroller General of the United States, Volume 31, p. 14, ¶ 7: "Acting Comptroller General Yates to the Librarian of Congress, July 18, 1951...stands the familiar canon of statutory interpretation that the sovereign is not affected by statutory provisions unless expressly named therein..."

The sovereign immunity court recorded in LASC BP-125551 since February 8th, 2011, proves Cynthia Mildred Miles is immune from all rules, regulations, reporting and international treaties. In other words, no matter the subject, no matter the government authority—her sovereign recognition, power and immunity are irrevocable and unconditional for ALL matters and to all authorities—except to God who is Jesus Christ.

Further, it's also well-established and agreed internationally, the suite of the Sovereign is wherever the sovereign or its retinue may be. This means her money, property and any of her agents (while acting as retinue) are also immune. See 'court' legal definition, "*In international law. 
